Donnie McLaughlin made a motion to accept the consent agenda items. Ed Marks seconded the motion. All in favor. Motion carried unanimously.

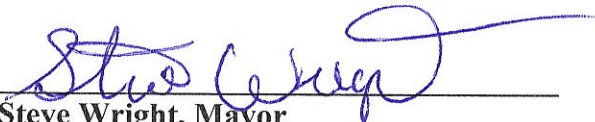

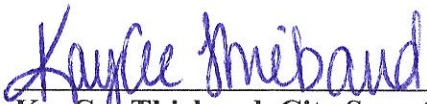
**VII. ADJOURN**
