THE COUNCIL MAY TAKE ACTION TO APPROVE PURCHASE OF THE VEHICLE BY THE CITY AND AUTHORIZE CITY MANAGER, BUSTER POLING, JR. TO SIGN AND DELIVER PURCHASE AGREEMENT DOCUMENTS AND OTHER DOCUMENTS NECESSARY AND APPROPRIATE TO CLOSE THE PURCHASE OF THE VEHICLE.
