VI. JOHN HOFFMAN, WATER SYSTEM CONSULTANT, WITH USG WATER SOLUTIONS, WILL GIVE A PRESENTATION TO THE LOCKNEY CITY COUNCIL REGARDING PROGRAMS AVAILABLE TO OUTSPREAD THE COST OF MAINTAINING MUNICIPAL WATER STORAGE FACILITIES. THE COUNCIL WILL DELIBERATE THE PROGRAMS AND MAY OR MAY NOT TAKE ACTION.

- VII. THE LOCKNEY CITY COUNCIL SHALL DELIBERATE AND CONSIDER AN ADDITION TO THE LOCKNEY CITY ORDINANCES CHAPTER 13 WITH THE ADDITION OF ARTICLE 13.06, REGARDING UTILITY SERVICES. THE COUNCIL MAY TAKE ACTION.
- VIII. THE LOCKNEY CITY COUNCIL SHALL DELIBERATE AND CONSIDER THE MINIMUM AMOUNT OF FINES AND PENALTIES LEVYIED BY THE CITY OF LOCKNEY MUNICIPAL COURT IN REGARD TO THE ADDITION OF ARTICLE 13.06. THE COUNCIL MAY TAKE ACTION.
- IX. THE CITY COUNICL SHALL DELIBERATE AND CONSIDER FUNDING TO ESTABLISH A SCHOOL RESOURCE OFFICER POSITION AT LOCKNEY ISD PROPOSED BY FLOYD COUNTY SHERIFF, PAUL RAISSEZ. THE COUNCIL MAY TAKE ACTION.
- X. THE LOCKNEY CITY COUNCIL SHALL DELIBERATE AND CONSIDER AN AMENDMENT TO THE MEMORANDUM AGREEMENT WITH KELLISON ROOFING AND CONSTRUCTION, LLC FOR ADDITIONAL FUNDS FOR THE COMPLETION OF THE LOCNEY ANIMAL SHELTER. THE COUNCIL MAY TAKE ACTION.
- XI. THE LOCKNEY CITY COUNCIL SHALL ENTER INTO A CLOSED SESSION IN ACCORDANCE WITH THE TEXAS GOVERNMENT CODE 551.074, PERSONNEL MATTERS CONCERNING THE VACANCY IN THE CITY MANAGER POSITION.
- XII. THE CITY COUNCIL SHALL RECONVENE INTO OPEN SESSION
- XIII. THE COUNCIL MAY TAKE ACTION TO FORMULATE A PLAN FOR INTERIM MANAGEMENT FOR THE CITY OF LOCKNEY AND DEPLOYMENT OF PERSONNEL TO ACCOMPLISH THE INTERIM MANAGEMENT PLAN.
